Adoption Agreement

Thank you for giving a home to one of our dogs. They have often been found abandoned or have been acquired from extremely deprived homes, thus we rarely know their full history or the conditions under which they have been trained. We can therefore give no assurance on any aspect of their temperament or long term physical condition. We have agreed to abide by all Veterinary advice that has been given. I am the new owner and I agree:

1. I will give the animal a good caring home and promise that he/she will not be raced, sold, worked, used for breeding, abandoned or given away. If I am unable to keep it in the agreed manner I will return it to EVESHAM GREYHOUND RESCUE or seek their approval for any new home I may find before passing it on.
2. My address may be visited at any reasonable time by a representative of EVESHAM GREYHOUND RESCUE to check upon the animal's welfare.
3. If my address changes EVESHAM GREYHOUND AND LURCHER RESCUE will be notified.
4. If the representative considers that the conditions under which the animal is kept are not satisfactory we will be allowed to repossess the animal.
5. The animal will wear an identify disk/tag at all times. (We suggest that the animal's name is NOT placed on the disc and that your home telephone number and address should be shown. If you wish just your own telephone number on one side and on the reverse the letters EGLR and 01386-853971). Should he/she go missing, I will inform the local authorities and EVESHAM GREYHOUND AND LURCHER RESCUE immediately and will take all possible steps to find him/her.
6. I am aware of the special responsibilities of owning a sighthound that has been trained to chase and will not allow him/her to be a nuisance or to worry livestock or small animals. I understand that I am liable for any damage that results from negligence.
7. I agree that the above animal has been chosen to live with us as part of the family and therefore should not be kept outside of our house in a kennel, run or anything of a similar construction.
8. All animals that are un-neutered at the time of adoption must be spayed/castrated within the time frame given by the rescues representative; breach of this may mean repossession of said animal.

I have read this agreement and have understood it. If I fail to comply in any way with the terms of the agreement or if EVESHAM GREYHOUND & LURCHER RESCUE considers it to be in the interest of the animal to do so, EVESHAM GREYHOUND & LURCHER RESCUE, at their absolute discretion, may repossess the animal.
